When the matter is taken up for hearing, Ms.Zainab Khan, counsel appearing on behalf of the petitioners would submit that the petitioners have filed by the aforesaid Interlocutor Application, wherein it is stated that at the intervention of elders, the petitioners have compromised the matter and the terms of compromise have been reduced into writing in the Memorandum of Understanding, dated 15.11.2017, and seeks permission of this Court to withdraw the main Criminal Petition.

3. Permission is accorded.

4. Accordingly, I.A.No.1 of 2020 is allowed as prayed for. Consequently, the Criminal Petition is dismissed as withdrawn granting liberty as sought by the petitioners.
