ORDER

This Application has been filed seeking to relax the condition imposed by this Court on 06.05.2021, insofar as directing petitioner to appear before the Station House Officer on every Saturday between 12.00 Noon and 05.00 P.M. until further orders.

While granting bail to petitioner by the order dated 06.05.2021, along with other conditions, petitioner was also directed to appear before the Station House Officer, Bachupally Police Station on every Saturday between 12.00 Noon and 05.00 P.M. till completion of the investigation.

None appears for the petitioner.

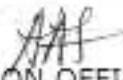
Learned Public Prosecutor submits that petitioner is appearing before the Station House Officer, as directed, from the date the said order was passed.
