Petition under Section 438 of Cr.P.C, praying that in the circumstances stated in the grounds filed in support of the Criminal Petition, the High Court may be pleased to grant Anticipatory Bail to the Petitioner/A-1 in the event of his arrest pending investigation and trial in Crime No.148 of 2021 on the file of Chatrinaka Police Station, Hyderabad

The petition coming on for hearing, upon perusing the Petition and the grounds filed in support thereof and the order of the High Court dated 02.06.2021 made in CrI.P. and upon hearing the arguments of Sri D.Sudharshan Advocate for the Petitioner and Public Prosecutor for the Respondent, the Court made the following.

ORDER**Heard both sides.**

In view of the reasons stated in the affidavit filed in support of the application, the surety amount, as directed by this Court vide order dated 02.06.2021 in CrI.P.No.3968 of 2021, is reduced from Rs.1,00,000/- to Rs.75,000/- (Rupees seventy five thousand only), and further, 10 days time is granted from today to petitioner/A1 to surrender before the Station House Officer, Chatrinaka Police Station, Hyderabad, as per the order dated 02.06.2021 in CrI.P.No.3968 of 2021, failing which, the police shall take coercive steps against the petitioner in accordance with law. No further extension will be granted. The other conditions imposed by this Court shall remain unaltered.

Accordingly, I.A., is ordered.
