ORDER:

This Tr.C.M.P. is filed seeking to withdraw F.C.O.P.No.1205 of 2019 on the file of Additional Family Court, City Civil Courts, Hyderabad, and to transfer the same to the Judge, Family Court, Khammam, where the petitioner-wife is residing.

Learned counsel for the petitioner submits that the petitioner filed a maintenance case and also a case for the offence punishable under Section 498-A IPC at Khammam
