Nagar.

Learned Assistant Public Prosecutor would submit that since the charge sheet has already been filed in the above crime, which has been registered as P.R.C.No.66 of 2021, nothing survives for further adjudication in the present Criminal Petition and it has become infructuous.

Miscellaneous applications, if any, pending shall stand closed.

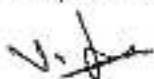
