Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ or order or direction, especially one in the nature of Writ of Mandamus:

- i) Declare the action of the respondents in not permitting the petitioners to appear for the process of selection for appointment to the post of Contract JLM in Nizamabad Circle as illegal and arbitrary
- ii) Consequently direct the respondents to permit the petitioners to appear for the process of selection for appointment to the post of Contract JLM and consider their cases on par with others and appoint them basing on the merit.

WPMP. NO: 1352 OF 2008

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondents to consider the cases of petitioners for appointment to the post of Contract JLM by permitting them to appear for the selection process, which is going on till 29-1-2008 or any other subsequent day and consider their cases on par with other basing on their merit, pending disposal of the above W.P.
