This Petition coming on for hearing, upon perusing the Memorandum of Grounds of Criminal Petition and upon hearing the arguments of Sri K.Pradeep Reddy, Advocate for the Petitioner and the Public Prosecutor on behalf of the Respondent No.1.

CRIMINAL PETITION NO.3695 OF 2019

ORDER:

This Criminal Petition is filed under Section 482 of the Code of Criminal Procedure seeking quashing of the proceedings in C.C.No.125 of 2019 on the file of the Judicial First Class Magistrate at Shadnagar.

A charge sheet came to be filed against the petitioner/accused for the offence punishable under Section 138 read with Section 141 of the Negotiable Instruments Act, 1881.

Though the present Criminal Petition is filed seeking quashing of entire proceedings, but learned counsel for the petitioner/accused restricts his prayer seeking dispensation of the presence of the petitioner/accused before the trial Court on every date of adjournment.

The learned Public Prosecutor submits that since the identity of petitioner/accused is not in dispute, her presence in the above case may not be necessary on every date of adjournment.

Having regard to the facts and circumstances of the case, the personal appearance of the petitioner/accused in C.C.No.125 of 2019 on the file of the Judicial First Class Magistrate at Shadnagar, is hereby dispensed with except on

the dates when her presence is specifically required by the Court.

With the above direction, the Criminal Petition is disposed of.

Miscellaneous applications, if any, pending shall stand closed.

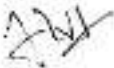
