Petition under Section 437 & 439 of Cr.P.C., praying that in the circumstances stated in the grounds filed in the Criminal Petition, the High Court may be pleased to extend the time for surrendering before the SHO P'S Sanathnagar, Cyberabad, enabling the petitioners to comply to the orders passed by this Hon'ble Court in CRLP.No 5563 of 2021 dated 27.07.2021 in so far as the condition that "The Petitioners/ A 7 to A3 are directed to surrender before the Station House Officer, Sanathnagar Police Station, Cyberabad District, within a period of 15 days from the date of this order, and on such surrender, the said Station House Officer shall release the petitioners/ A1 to A3 on bail on their executing a personal bond to the tune of Rs 1,00,000/- (Rupees one lakh only) each with two sureties for the like sum each to his satisfaction" and pass Pending disposal of CRLP No. 5563 of 2021, on the file of the High Court.

ORDER:

This application is filed seeking extension of time granted to surrender before the S.H.O., Sanathnagar Police Station, Cyberabad, enabling the petitioners/A.1 to A.3 to comply with the orders passed by this Court in Crl.P.No.2021, dated 27.07.2021.

Heard learned counsel for the petitioners and learned Public Prosecutor appearing for the respondent State.

For the reasons stated in the petition, the time granted to the petitioners to surrender before the Station House Officer, Sanathnagar Police Station, Cyberabad Commissionerate, is hereby extended by ten days from today.

Accordingly, this application is allowed.
