ORDER:

Heard the learned counsel for the petitioners and the learned Government Pleader for Revenue for the respondents. With their consent, the Writ Petition is disposed of at the admission stage.

This writ petition is filed seeking a writ of mandamus declaring the action of respondent No.3 in not issuing E-Passbooks to the petitioners in respect of the subject lands situated at Dameragidda Village, Chevella Mandal, Ranga Reddy District, for the last two years, as illegal and arbitrary.

Having regard to the fact that petitioners' names were already entered in Dharani Portal in respect of the lands in Survey Nos.26aa1, 26aa2, 27a and 27aa of Dameragidda Village, Chevella Mandal, Ranga Reddy District, without going into the merits or demerits of the case, the Writ Petition is disposed of directing the respondent No.3 to issue E-Passbook to the petitioners, if they are otherwise in order, within a period of four weeks from the date of receipt of a copy of this order.

Pending miscellaneous petitions, if any, shall stand closed.

There shall be no order as to costs.
