CONTEMPT CASE No. 1294 of 2019

ORAL ORDER:

Heard learned counsel for petitioner Sri P Srinivas Rao and learned counsel for respondents 1 to 4 and 6 to 9 Sri K Raghuvver Reddy.

2. This contempt case is filed alleging that respondents have violated the directions issued by this Court in WPMP No. 34378 of 2017 in WP No. 27678 of 2017 dated 21.8.2017. This Court taking note of the fact that unofficial respondents were unsuccessful before this Court regarding suspension of the orders of the Joint Collector dated 31.12.2010 on the issue of ORC, prima facie, it cannot be said that entries made by the Tahsildar in the year 2015 amounting to erroneous exercise of power warranting the Joint Collector to entertain the revision filed directly under Section 9 of the Act, 1971 and setting aside the order of the Tahsildar dated 7.1.2015, granted interim suspension as prayed for. However, this Court further observed that any decision taken in pursuant to the corrections made in the revenue records by the Tahsildar on 7.1.2015 and any action taken by the petitioners therein shall abide the result of the writ petition. Alleging that said interim orders are violated, this contempt case is filed.

3. Petitioner herein who is respondent no.15 in the writ petition alleges that respondents herein/writ petitioners have erected sign boards stating "*plots for sale*", that the character of the land was changed and divided into parts and leased out to third party and third party was inducted into possession to carry on business by making temporary constructions.

4. Even if what is stated by petitioner is correct, looking at the order passed by this Court, there was no such restriction imposed. This Court only observed that any decision taken in pursuant to the corrections made in the revenue records by the Tahsildar on 7.1.2015 and any action taken by the petitioners herein shall abide the result of

the writ petition. Therefore, what is alleged does not amount to committing contempt of the orders of this Court warranting interference of this Court. Accordingly, contempt case is closed. Miscellaneous petitions, if any pending, are closed.

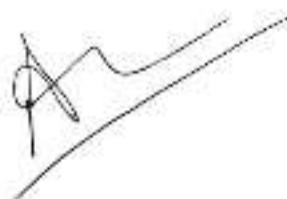
