Therefore this Civil Revision Petition is dismissed as infructuous. No order as to costs. Miscellaneous petitions pending, if any shall stand closed.

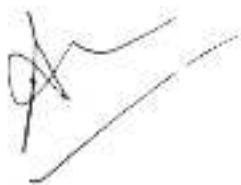
