This Criminal Petition, under Section 482 of the Code of Criminal Procedure, 1973, is filed by the petitioner/accused seeking to quash the proceedings against him in Crime No.158/2020 of Kandukur Police Station, Rachakonda, registered for the offences under Sections 406, 417 and 420 IPC.
