ORDER:

Heard learned counsel for the petitioner.

2. Perused the record. Notice of the respondent sent from the Court is served, called absent. No representation.

3. This transfer CMP is filed by the petitioner/wife under Section 24 of C.P.C. for withdrawal of HMOP.No.68 of 2020 pending on the file of Senior Civil Judge's Court, Medak and to transfer the same to the Court of Judge, Family Court, City Civil Court, Hyderabad. As per the averments in the affidavit filed in support of the petition, it appears that the marriage of the petitioner with respondent was performed about 22 years back. They were blessed with two children. Subsequently, he deserted the wife and children and they are forced to stay at Hyderabad. She is a house wife. She has no source of income.

4. Therefore, considering the facts of the case and the convenience of the petitioner/wife, I deem it fit to accept the request of the petitioner.

5. In the result, the Transfer CMP is allowed. HMOP.No.68 of 2020 pending on the file of Senior Civil Judge's Court, Medak is ordered to be withdrawn and transfer the same to the Court of Judge, Family Court, City Civil Court, Hyderabad for disposal in accordance with law. The learned Senior Civil Judge, Medak shall transmit the entire record duly indexed within one month from the date of receipt of a copy of this order. Pending miscellaneous applications, if any, shall stand closed.

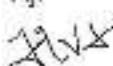
