2. Accordingly, the Appeal is dismissed for as not pressed. No order as to costs. As a sequel, the miscellaneous petitions pending if any shall stand closed.

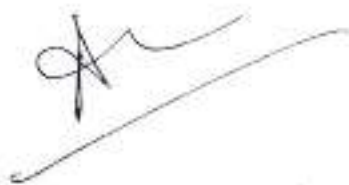
