Petition under Section 482 of Cr.P.C praying that in the circumstances stated in the Memorandum of Grounds of Criminal Petition, the High Court may be pleased to grant stay of all further proceedings including arrest of the petitioner/ accused No.4 in Crime No. 326 of 2021 on the file of Police Station Saroornagar WPS, Rachakonda Commissionerate pending disposal of Criminal petition in the interest of justice.

This Petition coming on for hearing, upon perusing the Memorandum of Grounds of Criminal Petition and upon hearing the arguments of Sri P.V. Subramanyam, Advocate for the Petitioner and the ^{Adv.}Public Prosecutor on behalf of the Respondent No.1 and of the Respondent No.2 not appearing in person or by Advocate.

The Court made the following: ORDER

CRIMINAL PETITION No.8160 of 2021

ORDER

This Criminal Petition, under Section 482 of the Code of Criminal Procedure, 1973, is filed by the petitioner/A4 seeking to quash the proceedings against her in Crime No.326 of 2021 of Saroornagar Women Police Station, Rachakonda Commissionerate, registered for the offences under Sections 498A, 323 and 506 of IPC and Sections 3 and 4 of Dowry Prohibition Act, 1961.

2. Heard. Perused the record.
3. In the course of submissions, it is brought to the notice of this Court by the learned Assistant Public Prosecutor that investigation in the subject crime was completed, charge-sheet was filed on 21.09.2021 before the V Metropolitan Magistrate, L.B. Nagar and C.C.No.7805 of 2021 was also assigned.
4. Under these circumstances, nothing survives for adjudication in this Criminal Petition. However, liberty is granted to the petitioner/A4 to work out the remedies available under law.
5. With the above observation, the Criminal Petition is disposed of.
