Petition Under Section 24 of the C.P.C. praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to withdraw the HMOP No.138/2021 from the Court of learned Additional Senior Civil Judge, Kothagudem and transfer the same to the Court of learned Judge, Family Court, LB Nagar to be tried along with Restitution OP No. 1236/2020 for disposal according to law

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to stay all further proceedings in HMOP No.138 of 2021 on the file of learned Additional Senior Civil Judge, Kothagudem pending disposal of the Transfer Civil Miscellaneous Petition.

This petition coming on for hearing, upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of Sri M.Anand Kumar, Advocate for the petitioner and of Sri S.Rama Mohan Rao, Advocate for the Respondent.

ORDER:

Heard learned counsel for petitioner and respondent.
Perused the record.

This Tr.CMP is filed under Section 24 of CPC by the petitioner-husband with a request to withdraw HMOP.No.138/2021 pending on the file of the learned Additional Senior Civil Judge, Kothagudem and to transfer the same to the Judge, Family Court, L.B.Nagar, R.R.District, to be tried along with OP.No.1236/2020 for disposal in accordance with law.

In the course of arguments, learned counsel for the respondent has fairly conceded that the HMOP.No.138/2021 may be withdrawn from the file of the learned Additional Senior Civil Judge, Kothagudem and transferred to the Court of Judge, Family Court at L.B.Nagar, R.R.District to be tried along with OP.No.1236/2020 pending on the file of that Court for restitution of conjugal rights between the same parties.

Therefore, in such circumstances, considering the convenience of the petitioner-wife and the consent of the respondent-husband, Tr.CMP is allowed and

HMOP.No.138/2021 pending on the file of the learned Additional Senior Civil Judge, Kothagudem, is ordered to be withdrawn and transferred to the Judge, Family Court, L.B.Nagar, R.R.District, to be tried along with OP.No.1236/2020. Learned Additional Senior Civil Judge, Kothagudem, shall transmit the entire record duly indexed within one month from the date of receipt of a copy of this order. In the circumstances there shall be no order as to costs.

Pending miscellaneous applications, if any, shall stand closed.

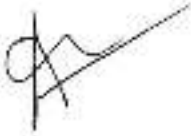
