Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue Writ or direction preferably Writ of mandamus declaring the inaction of the respondent no.3 in conducting survey and fixing boundaries on the basis of mee seva F-line application no. DER022100662699 dt.22-6-2021 in respect of land of petitioner i.e. land admeasuring Ac.4-00 in Sy.no.419/E/1 and 419/E/2 situated at Gubbagurthy Revenue village, Konijerla (M) Khammam District as illegal, arbitrary, violative of principles of natural justice and consequently direct the respondent no.3 to conduct survey and fix boundaries and furnish copy of the survey report within reasonable time to the petitioner.

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct the respondent no.3 to consider and dispose of the mee seva F-line application no. DER022100662699 dt.22-6-2021 submitted by the petitioner for conducting survey and fix boundaries to the land of the petitioner i.e. land admeasuring Ac.4-00 in Sy.no.419/E/1 and 419/E/2 situated at Gubbagurthy Revenue village, Konijerla (M) Khammam District, pending disposal of the writ petition in the interest of justice.

ORDER:

Heard the learned counsel for the petitioner and the learned Government Pleader for Revenue for all the respondents. With their consent, the Writ Petition is disposed of at the stage of admission.

2. Aggrieved by the inaction of respondent No.3 in conducting survey and demarcation of the land of the petitioner admeasuring Ac.4-00 gts in survey No.419/E/1 and 419/E/2 situated at Gubbagurthy Revenue Village, Konijerla Mandal, Khammam District inspite of submission of F-Line application vide No. DER022100662699, dated 22.06.2021, the present writ petition is filed.

3. The learned Government Pleader for Revenue on instructions submits that the official respondents have already initiated action and next date of survey is put on 26.11.2021.

4. Having regard to the fact that the official respondents have already initiated action and survey date is fixed, the official respondents are directed to complete the said survey pursuant to the F-line application No.DER022100662699, dated 22.06.2021 submitted by the petitioner, as expeditiously as possible, preferably within a period of eight weeks from the date of receipt of a copy of this order. It is needless to mention that before undertaking any survey, the authorities shall put the petitioner as well as the neighbouring landowners on notice, and take into account the work memos, if any, filed by any of the parties.

Accordingly, the writ petition is disposed of. The miscellaneous petitions pending, if any, shall stand closed. There shall be no order as to costs.
