1 There is no representation for the petitioner on 11.11.2020, 28.6.2021 and even today also. It seems that the petitioner is not interested in pursuing the matter.

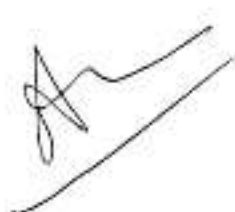
