Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to pass an order or direction or writ in the nature of mandamus duly declaring the action of the respondents in conducting the counselling process for allotting the cadres /postings under G.O.Ms.No. 317 dated 06-12-2021 as per the circular memo vide No. 1655/SPF-1/2021-7 dated 23-12-2021, without completing the process of disposing of applications of consider the spouse cases as per Memo vide No.1655/SPF-1/2021-5 dated 22-12-2021 as illegal arbitrary and against the principles of natural justice and consequently direct the respondents to dispose the application of the petitioner seeking spouse case, before proceeding with the counselling under circular memo vide No. 1655/SPF-1/2021-7, dated 23-12-2021 in the interest of the justice.
