2. Accordingly the appeal is dismissed for non-prosecution. No order as to costs. As a sequel, the miscellaneous petitions pending if any shall stand closed.

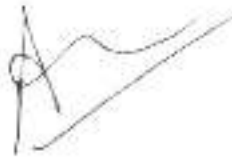
