Petition under Article 226 of the Constitution of India praying that in the circumstances stated in the affidavit filed therewith, the High Court may be pleased to issue a writ or order or direction, especially one in the nature of Writ of Mandamus: i) declare the action of the 3rd respondent in not releasing the Tractor No.20 PTO HP to the petitioner, which was sanctioned to him under FM (NSP) Scheme, as illegal and arbitrary ii) consequently direct the 3rd respondent to release the Tractor No.20 PTO HP to the petitioner and reimburse the interest amount of Rs.35,571/-, which is being charged by the bank authorities.
