These are the petitions filed under Section 439 Cr.P.C. for grant of regular bail to the petitioners namely Kashish Duggal @ Kaka Kirach and Rahul Sehdev @ Laloo in FIR No. 297 dated 24.10.2020 under Sections 307, 452, 323, 324, 325, 326, 148 and 149 of the IPC, registered at Police Station Sadar Amritsar, Amritsar City, District Amritsar, Punjab, respectively.

Status report by way of affidavit of Assistant Commissioner of Police, Airport, Amritsar City, filed in the Court today, is taken on record.

Learned counsel for the petitioner has also placed on record the opinion of the Doctor as well as the compromise dated 06.07.2021, which are also taken on record.

Learned counsel for the petitioners submits that as per the allegations in the FIR, registered at the instance of complainant-Bhanu Ram, it is stated that on 24.10.2020, when he was working in a shop and his uncle Vinod Kumar was standing nearby, suddenly a white car came and Kashish Duggal @ Kaka Kirach (petitioner) came their along with three more persons and they were armed with weapons like Datar, Kirpan and sticks. Thereafter, two more persons accompanying them came on the motorcycle armed with Kirpan. Petitioner Kashish Duggal @ Kaka Kirach exhorted to teach him a lesson for having enmity with him and out of fear he ran away towards the first floor of the shop of Rajat Sharma. Kashish Duggal @ Kaka Kirach along with one more person chased him, whereas, remaining accused stayed on the ground floor and then he was pushed on the ground floor and was given injuries.

Learned counsel for the petitioners further submits that the petitioner Kashish Duggal @ Kaka Kirach is in judicial custody since 09.11.2020, whereas, petitioner Rahul Sehdev @ Laloo is in judicial custody since 10.02.2021.

Learned State counsel, has verified the factum of the compromise between the parties and on instructions from ASI Balwinder Singh submits that the matter has been amicably settled between them.

I have heard learned counsel for the parties.

Without commenting anything on the merits of the case and considering the facts and circumstances of the present case, both the instant petitions are allowed. The petitioners are ordered to be released on regular bail

on their furnishing bail/surety bonds to the satisfaction of the trial Court/Duty Magistrate/Illaqa Magistrate, concerned.
