Case is taken up for hearing through video conferencing.

CRM-2501-2021 has been filed under Section 482 Cr.P.C. for
modification/correction of the order dated 25.01.2021 passed by this Court.

On the oral request of the learned counsel for the applicant-
petitioner, hearing of the present application is preponed from 05.03.201 to
today, itself.

The present petition has been filed seeking direction to the
official respondents No.2 and 3 to conclude the investigation and submit
the final report in case bearing FIR No.54 dated 12.08.2019 registered
under Sections 326, 325, 323, 148 and 149 IPC at Police Station Verowal,
District Tarn Taran, in a time bound manner after effecting the arrest of
accused/respondents No.6 to 11, who are causing threats to the life of the
petitioner and his family, and also directing the respondents No.4 and 5 not

to harass the petitioner by conducting 4th and 5th inquiry in the said FIR on the frivolous applications moved by the accused persons. The petitioner had earlier approached this Court by way of CRM-M-31956-2020 for issuance of directions to the officials respondents to conclude the investigation and submit final report in the above said FIR in a time bound manner. This Court, vide order dated 13.10.2020, disposed of the said petition with a direction to respondent No.2-Senior Superintendent of Police, Tarn Taran, to decide the representation dated 14.09.2020 moved by the petitioner, within a period of 25 days after receiving the certified copy of the order, in accordance with law.

In the present case, vide order dated 25.01.2021, this Court had directed respondent No.2-Senior Superintendent of Police, Tarn Taran, to conduct a fresh inquiry into the matter in view of the guidelines dated 01.04.2008 (Annexure P-8) issued by the Director General of Police, Punjab.

In compliance of the order dated 25.01.2021 passed by this Court, a short affidavit of the Senior Superintendent of Police, Tarn Taran, has been filed in the Registry. The same is taken on record.

It is stated in the said short affidavit that a fresh inquiry will be conducted in the present matter in accordance with the aforesaid guidelines dated 01.04.2008 (Annexure P-8).

In view of the above, the present petition is disposed of with a direction to respondent No.2 that while initiating inquiry proceedings, in pursuance of the order dated 25.01.2021, the guidelines dated 01.04.2008 (Annexure P-8) issued by the Director General of Police, Punjab, will be

taken into consideration.

It is also made clear that the inquiry pending before respondent No.5-AIG (Zonal-Crime), Amritsar, will be concluded as per the aforesaid guidelines dated 01.04.2008.
