The petitioner is seeking regular bail in FIR No.519 dated 16.08.2020, under Sections 363, 366A IPC and Sections 4, 17, 21 of the POCSO Act, 2012 registered at Police Station City Yamunanagar, district Yamunanagar.

Learned counsel for the petitioner contends that the petitioner is not named in the FIR wherein it is mentioned that co-accused, namely, Vikram had assaulted the victim. The victim in her statement under Section 164 Cr.P.C. as well as in her deposition before the trial Court as PW-2, did not level any allegation against the petitioner and did not support the prosecution case *qua* the involvement of the petitioner. He also contends that the petitioner is in custody for over 5 ½ months and is not involved in any other criminal case.

Learned State counsel, upon instructions from ASI Kuldeep Singh, contends that the petitioner is alleged to have helped the co-accused Vikram in the commission of the offence. She, however, is not in a position to

controvert the submissions of learned counsel for the petitioner that the victim did not depose with regard to the involvement of the petitioner either in her statement under Section 164 Cr.P.C. or as PW-2 before the trial Court. She also contends that 04 out of 18 prosecution witnesses have been examined.

Heard through video conferencing.

In view of the submissions of the learned counsel for the petitioner, especially when the petitioner is not named in the FIR, the victim has not deposed qua the involvement of the petitioner, he is in custody for over 5½ months, he is not involved in any other criminal case, the COVID-19 pandemic and the conclusion of the trial is likely to take some time, I deem it a fit case to grant the concession of regular bail to the petitioner.

Therefore, without expressing any opinion on the merits of the case, the instant petition is allowed. The petitioner is ordered to be released on regular bail on his furnishing requisite bonds to the satisfaction of the trial Court/Duty Magistrate concerned.
