The hearing of the case was held through video conferencing on account of restricted functioning of the Courts.

The petitioner seek employment as a Post-Graduate Teacher in Chemistry subject.

The petitioner filed the Civil Writ Petition No.598 of 2014 which was disposed of on 20.09.2017, directing the respondents to consider the case of the petitioner and other similarly situated candidates, if they fulfill all other criteria and also come in the zone of consideration as per their merits.

Pursuant thereto, the case of the petitioner has been considered by the Haryana Staff Selection Commission and rejected with the following observations which have been extracted in her representation:-

1	Hira Lal Yadav, Balika Inter College Sarojani Nagar, Lucknow.	07.10.2004 to 29.07.2015	Upon the perusal of the entire matter, only it can be said that the experience certificate which has been countersigned by the officers, but they have not verified their signatures. The experience certificate which have been given for the verification is bearing written as Non-Aided recognized and whereas the letter bearing No.Vay Saha/P.A.2427-28/2018/2018 dated 14.06.2018 which has been received by post is bearing written as Aided recognized. The school even could not presented the appointment letter pertaining to Smt. Sukhdarshan, attendance register pertaining to salary. In this situation, the experience certificate issued to Smt. Sukhdarshan daughter of Fateh Singh cannot be admitted as valid.
2	N.R.J.V.M.V. Jhojhu Kallan (Bhiwani)	01.12.2006 to 31.03.2007	The Commission is of the view that Smt. Sukhdarshan D/o Sh. Fateh Singh, village Balkara, P.O. Mouri, Charkhi Dadri, Bhiwani of NRJ S.S.School has not worked in the said school as PGT (Chemistry) during the claimed period.

It may be noted here that the petitioner has neither annexed the complete order of the Haryana Staff Selection Commission nor annexed the order passed by the Additional Chief Secretary.

Keeping in view the aforesaid facts, disputed questions of facts are likely to be involved.

Hence, the petitioner is relegated to the alternative remedy.

Disposed of accordingly.
