16.02.2021, report of the Secretary, District Legal Services Authority,
Ludhiana, dated 12.03.2021, has been filed in Court, wherein it has been
stated as follows:

“In view of the order dated 16.02.2021, summons were
issued to Kanika Aggarwal, D/o Suresh Kumar Aggarwal
to record her statement. Summons were received by
Suresh Kumar Aggarwal, father of Kanika Aggarwal but
she did not appear to record her statement. Her father
Suresh Kumar Aggarwal appeared on 12.03.2021 and got

recorded his statement that Kanika Aggarwal had gone to Delhi with her mother from where she went with the petitioner Gurpreet Singh S/o Surinder Singh R/o H.No.37,St. No.1, Sant Cheema Singh Nagar, Dashmesh Puri, Ludhiana on 03.03.2021 at 3:30-4:00 pm, without any intimation to them. She got performed her marriage with Gurpreet Singh S/o Surinder Singh and after marriage she is residing with her husband in her matrimonial house. Suresh Aggarwal, father of Kanika Aggarwal further states that he never met Kanika Aggarwal after 03.03.2021 as he has no concern with her. So, the statement of Kanika Aggarwal could not be recorded due to her absence.”

In the light of the above, the present appeal has been rendered infructuous. Disposed of as such.
