Case is taken up for hearing through video conferencing.

CRM-31128-2019

Prayer in the application is for adding Sections 420, 467, 468 and 471 IPC, which were added in FIR No.294 dated 24.11.2018 vide DDR No.29 dated 12.09.2019, in the head note and prayer clause of the petition and in the order dated 04.02.2019 passed by a Coordinate Bench of this Court.

Application is allowed, as prayed for.

Registry is directed to make the necessary corrections, accordingly.

CRM-M No. 5329 of 2019

Prayer in this petition is for grant of anticipatory bail in case FIR No. 294 dated 24.11.2018, registered under Sections 406, 408, 201, 120-B IPC, and Sections 420, 467, 468 and 471 IPC, added vide DDR No.29 dated 12.09.2019, at Police Station Sadar Tarn Taran, District Tarn Taran.

Vide order dated 04.02.2019, passed by a Coordinate Bench of this Court, *ad interim* anticipatory bail was granted to the petitioners. However, subsequently, new offences under Sections 420, 467, 468 and 471 IPC were added vide DDR No.29 dated 12.09.2019. Vide order dated 04.10.2019 passed by a Coordinate Bench, the arrest of the petitioners qua the newly added offences was stayed. Still later, vide order dated 27.02.2020, the petitioners were directed to join the investigation on 03.03.2020 at 10:00 a.m.

Today, learned counsel for the petitioners submits that in compliance of the aforesaid orders, the petitioners have joined the investigation.

Learned State counsel, on instructions from SI Kewal Singh, states that the petitioners have joined the investigation and are not required for any further investigation.

In view of the above, the order dated 04.02.2019, granting *ad-interim* anticipatory bail to the petitioners shall also be deemed to have been granted for the offences under Sections 420, 467, 468 and 471 IPC, added later on vide DDR No.29 dated 12.09.2019. Accordingly, the order dated 04.02.2019 is made absolute, subject to the conditions laid down in Section 438 (2) Cr.P.C.
