Prayer in CM-4376-CWP of 2021 is for withdrawal of the writ
petition which is listed for hearing on 28.04.2021 after issuance of notice of
motion.

Notice of the application.

Mr. Jagbir Malik, Addl.AG., Haryana, accepts notice on behalf
of non-applicant-respondent no.1.

Mr. R.S.Madaan, Advocate, accepts notice on behalf of non-
applicant-respondent no.2.

It is submitted in the application that the petitioners have been
assured by respondent no.2 that their prayer for release of the amount shall
be considered only after the writ petition is withdrawn.

Learned counsel for non-applicant-respondent no.2 submits that
there is no such assurance in this regard. In-fact, communication dated

26.11.2020, has been addressed to the Competent Authority-cum-District Revenue Officer, Panchkula (Haryana) and communication dated 10.11.2020 to the Additional Chief Secretary, Revenue and Disaster Management, Government of Haryana, Chandigarh claiming an attempt to favour the land owners unjustly. Learned counsel for respondent no.2 states that it is specifically mentioned in communication dated 26.11.2020 that the Competent Authority-cum-District Revenue Officer, has no authority to change or revisit the award passed by his Predecessor vide orders/ Award no.4 of 29.07.2010 and Award no. 12 of 15.11.2010. Certain discrepancies in the measurement of the land acquired are also pointed out therein.

At request of learned counsel for the parties, hearing of the main petition is preponed from 28.04.2021 for today itself.

Learned counsel for the petitioners submits that the petitioners be permitted to withdraw this writ petition simplicitor.

In view of the above, application i.e. CM-4376-CWP of 2021 is allowed and CWP No. 4126 of 2021 is dismissed as withdrawn.
