This is fourth petition for grant of bail pending trial to the petitioner in a criminal case arising from FIR No.107, dated 11.07.2019, registered under Section 21 of the Narcotic Drugs and Psychotropic Substances Act, 1985 at Police Station City Patti, District Tarn Taran, Punjab.

On 24.09.2020, while dismissing the third petition for grant of bail filed by the petitioner, the following order was passed:-

“The hearing of the case was held through video conferencing on account of restricted functioning of the Courts.

This is 3rd petition for grant of bail to the petitioner pending trial in a criminal case arising from FIR No.107, dated 11.07.2019, registered under Section 22/61/85 of the Narcotic Drugs and Psychotropic Substances Act, 1985 at Police Station City Patti, District Tarn Taran.

The first petition was dismissed on 30.10.2019 vide CRM-M-38603 of 2019 with the following order:-

“Petitioner prays for grant of regular bail in FIR No.107 dated 11.07.2019 registered under

Sections 22/61 of the Narcotic Drugs and Psychotropic Substances Act, at Police Station City Patti, District Tarn Taran.

As per case of the prosecution, 265 grams of heroin was recovered from the conscious possession of the petitioner in the presence of Deputy Superintendent of Police, Investigation, Tarn Taran. Report of the Forensic Science Laboratory, has been received confirming that the narcotic recovered is Heroin. Recovered material is commercial category as notified by the Central Government. Hence, no ground to grant concession of bail to the petitioner is made out.

Accordingly, the present petition is dismissed.”

The second petition was dismissed on 26.02.2020 vide CRM-M-6892-2020 with the following order:-

“This is second petition for grant of regular bail to the petitioner in FIR No. 107 dated 11.07.2019, registered under Section 21 of the Narcotic Drugs & Psychotropic Substances Act, 1985 at Police Station City Patti, District Tarn Taran. The first petition for grant of regular bail, filed by the petitioner, was dismissed on 30.10.2019. No fresh ground for grant of regular bail after order dated 30.10.2019 is made out.

Dismissed.”

No fresh ground for grant of bail to the petitioner is made out. Dismissed.”

No fresh ground for grant of bail is made out. Hence, dismissed.
