Mr. H.S. Multani, AAG, Punjab appearing on advance notice submits that DDR No. 33, dated 15th February, 2021 under Sections 323, 427 and 149 of the Indian Penal Code, 1860 has been reported at Police Station Garhdiwal, District Hoshiarpur.

Learned counsel for the petitioner submits that non cognizable offences have intentionally been invoked to help the private respondents.

However, after realizing that there are remedies available, learned counsel for the petitioner seeks permission to withdraw the present petition with liberty to avail remedies in accordance with law.

Dismissed as withdrawn with liberty as prayed for.
