The case has been taken up for hearing through video conferencing.

The petitioners, claiming themselves to be aged about 24 and 25 years respectively, have approached this Court seeking protection of their life and liberty on the averments that the petitioners performed marriage on 17.03.2021 at Gurudwara Dashmesh Pita Pathsahi Dasvi (Regd.), Village Singha Devi, Tehsil Kharar, District Mohali as per Sikh rites and ceremonies against the wishes of respondent No.5 and the petitioners are apprehending threat to their life and liberty at his instance.

While issuing notice of motion vide order dated 22.03.2021 this Court had directed respondent No.2-Senior Superintendent of Police, Hoshiarpur to look into the grievances of the petitioners as set out in the petition and also expressed in the representation dated 17.03.2021 (Annexure P-5) and take appropriate action for protection of their life and liberty as may be warranted by the circumstances.

Learned Counsel for the petitioners has sent copy of Adhar Card of petitioner No.1 and copy of Passport of petitioner No.2 through e-mail printout of which are taken on record.

Learned Counsel for the petitioner has submitted that on his oral request vide order dated 22.03.2021 date of birth of the petitioner No.2 was corrected as 02.09.1995 instead of 02.09.1996 but actual date of birth of petitioner No.2 is 02.09.1996 which may be corrected again.

Learned State Counsel has no objection to this submission as in the status report filed by way of affidavit of Sh. Gurpreet Singh, PPS, Deputy Superintendent of Police, Sub-Division Hoshiarpur it has been mentioned that actual date of birth of petitioner No.2 is 02.09.1996. Therefore, request is allowed and date of birth of petitioner No.2 is ordered to be corrected again as 02.09.1996 instead of 02.09.1995.

In the status report, it has been mentioned that the petitioners handed over their affidavits to the police in which they stated that they are living happily as husband and wife at Village Pholahi, District Hoshiarpur and now they have no apprehension of danger to their life and liberty from their parents or relatives. They do not want any police security and in case they need security, they will approach the local police.

In the status report, it has also been mentioned that respondent No.5, father of petitioner No.2, also filed affidavit that he has no objection to the marriage of the petitioners and will not harass them.

Learned Counsel for the petitioners has submitted that the petitioners do not want to continue with the present petition and the same may be dismissed as withdrawn with liberty to file fresh petition in case of apprehension of danger to their life and liberty from their parents or relatives.

Dismissed as withdrawn with liberty as aforesaid.
