The instant petition is for quashing of FIR No. 14, dated 29.08.2019, lodged under Sections 498-A, 406, 494, 420, 120-B of IPC, registered at Police Station Women Ferozepur, District Ferozepur (Annexure P-1) and all the consequential proceedings arising out of the same, on the basis of compromise dated 06.03.2021 (Annexure P-2) arrived at, between the parties.

Vide order dated 24th August, 2021 of this Court, the parties were directed to appear before the learned Illaqa Magistrate/trial Court on 23rd September, 2021, to get their statements recorded, regarding the compromise arrived at, between them.

Learned counsel for the petitioners has submits that in view of the compromise arrived at between the parties, the disputes between the parties have been resolved and a joint petition under Section 13-B of the

Hindu Marriage Act, 1955, stands filed before the Family Court concerned.

Report has since been received from the learned CJM, Ferozepur, in pursuance to the direction of this Court, wherein, the factum of the compromise arrived at between the parties stands verified and confirmed. As per the report compromise has indeed been effected between the parties and the same is without any pressure or coercion and out of their free will and the complainant has also made statement to the effect that she would have no objection if the FIR *qua* the accused-petitioners is quashed. The trial Court has annexed the copies of the statements of the parties in original along with its report.

Learned State counsel too submits that there are no other accused other than the petitioners and respondent No.2 is the only aggrieved person in the FIR in question.

In view of the report of the learned CJM, Ferozepur, and the principles laid down by the Apex Court in **Gian Singh Vs. State of Punjab and others (2012) 10 SCC 303**, and also by the Full Bench of this Court in **Kulwinder Singh and others Vs. State of Punjab and another, 2007(3) RCR (Criminal) 1052**, the instant petition is allowed. The aforesaid FIR and all consequential proceedings arising out of it, are quashed.

Needless to say the parties shall remain bound by the terms of compromise and their statements recorded before the Court below.
