Prayer in this petition is for grant of regular bail in FIR No.450 dated 29.07.2020 under Sections 307, 323, 325, 506, 34 IPC, registered at Police Station Assandh, District Karnal.

Learned counsel for the petitioners, at the very outset, seeks permission to withdraw the present petition qua petitioner No.2 Aman.

Ordered accordingly.

Learned counsel for the petitioners submits that as per allegations in the FIR, the police received an information from Govt. Hospital that victim Pardeep was admitted in hospital on account of sustaining injuries in an assault. Later on, Satpal father of the victim, recorded his statement that on 28.07.2020,

2-3 boys came on a motorcycle, where his son was working. They were having muffled faces and gave merciless beatings with hockey and sticks. On hearing the noise, some persons came there and thereafter, the assailants fled away. It is further submitted that later on, co-accused Aman was arrested and on his disclosure statement, name of petitioner No.1 Gurjeet Singh @ Harsh surfaced.

Learned State counsel has filed the custody certificate dated 05.09.2021 in the Court today and on the basis of status report by way of affidavit of Deputy Superintendent of Police, Assandh, Karnal, has stated that petitioner No.2 was arrested on 02.12.2020 and thereafter, he suffered a disclosure statement naming petitioner No.1. It is submitted that next date before the trial Court for framing of charge is fixed for 21.10.2021.

After hearing learned counsel for the parties, without commenting anything on merits of the case and considering the fact that petitioner No.1 was nominated in the FIR on the basis of disclosure statement of co-accused Aman, this petition is allowed qua petitioner No.1 only, as same is dismissed as withdrawn qua petitioner No.2 Aman. Petitioner No.1 Gurjeet Singh @ Harsh is directed to be released on regular bail subject to furnishing his bail/surety bonds to the satisfaction of the trial Court/Illaq Magistrate/Duty Magistrate, concerned.

Petition is disposed of.
