This is an application for placing on record letter dated 29.12.2020 (Annexure P-14), letter dated 02.06.2021 (Annexure P-15) providing all the record of AY 2004-05 and further for Assessment Year 2007-08 for adjusting the advance tax paid for AY 2007-08 in Form-3 issued under the Direct Tax Vivad Se Vishwas Scheme and for exemption from filing the certified/fair typed copy of Annexures P-14 and P-15.

For the reasons recorded in the application, which is duly supported by an affidavit, the same is allowed.

Annexures P-14 and P-15 are taken on record.

Main case

This writ petition has been filed by the petitioner for issuance of directions to the respondents to rectify Form 3 dated 19.04.2021 (Annexure P-13).

Today letter dated 19.07.2021 has been placed on record by Ms. Urvashi Dhugga, Sr. Standing Counsel for the respondents, as per which, it has been mentioned that after verification, it has been clarified that there was no wrong claim by the Assessee and credit for this challan has been given in AY 2007-08. It has further been mentioned that Form-3 earlier issued to the Assessee is proposed to be revised and a request mail has already been sent to cancel the earlier issued Form-3. Revised Form-3 giving credit of Rs.57,26,440/- shall be issued as soon as the earlier Form-3 is cancelled. It is further mentioned that ITBA e-filing portal is not functioning and the process is likely to take some time.

In this view of the matter, nothing survives in the present writ petition, at this stage.

Accordingly, the present writ petition is disposed of having been rendered infructuous.

Since the main case has been decided, the pending Civil Miscellaneous Application, if any, also stands disposed of.
