MAIN CASE:

Present petition has been filed under Articles 226/227 of the Constitution of India for issuance of a writ in the nature of certiorari quashing the advertisement No.8 dated 04.06.2020 (P13) issued by respondent No.3 to the extent of inviting applications for filling up 20 posts of Punjab Civil Service (Executive Branch), on the premise that 3% reservation for sports-persons has not been provided. Further prayer is to issue a fresh advertisement after giving due weightage to sports category as prescribed under Rules.

Counsel for the petitioners, on instructions, has apprised the Court that since new advertisement No.14 dated 08.12.2020 has been issued, therefore, he wishes to withdraw the present petition with liberty to file fresh one with better particulars.

The above factual position is not disputed by learned State counsel.

Dismissed as withdrawn with liberty aforesaid.
