SUVIR SEHGAL, J.(ORAL)

The Court has been convened through video conferencing due to Covid-19 pandemic.

Instant petition has been filed under Article 226/227 of the Constitution of India seeking issuance of a writ in the nature of mandamus directing the official respondents to act upon the complaint/representation, Annexure P-3, which is pending before them. A further prayer has been made that the deduction of house rent allowance of the petitioner be stayed till the time the allotted government accommodation is repaired and made habitable.

Notice of motion.

Advance copy of the petition has been served upon the respondents, who have put in appearance through Mr. Vishal Munjal, Advocate. He has filed an affidavit of Er. Jigna K. Sanghadia, Superintendent Engineer, Construction Circle-II, Engineering Department, UT, Chandigarh, wherein it has been *inter alia* deposed as under:-

“6. That the deponent hereby gives point wise response to the works that the Petitioner has mentioned in his representations Annexures P-3 and P-4, as follows:-

(i) Cement work, repair of corner and other cement work:- The deponent states that the requisite repair work/cement work shall be carried out wherever it is required to be done.

(ii) Floor tiles are broken and needs to be replaced :- The floor tiles which are broken will be replaced.

(iii) Kitchen cupboard and other wood works :- Damaged cupboards will be repaired and other wood work wherever damaged shall be repaired/replaced.

(iv) Windows are in totally dilapidated condition and required complete replacement. Glasses of windows are also required to be changed as the same are also broken :- Damaged windows will be replaced. Broken glass of the window shall be replaced with the new glass.

(v) Ventilators are broken and needs to be replaced :- Ventilators which are broken will be repaired and if unrepairable, the same shall be replaced.

(vi) Change of Toilet Seat :- If required can be changed.

(vii) Whitewash/Paint :- Will be carried out.

7. That the deponent shall get the aforesaid works done. However, for carrying out the same, the Petitioner shall be required to make available the site to the deponent department. All the repair works shall be carried out within a period of 20 days after making the site available to the deponent. ”

In view of the fair stand taken by the respondents in their affidavit, no further order is called for.

Writ petition stands disposed of.
