Petitioner has approached this Court with a prayer for issuance
of a writ of mandamus directing respondent No.2-Haryana Shahri Vikas

Pradhikaran (HSVP) to complete the leasing process of auditorium (popularly known as Kingdom of Dreams) in City Centre, Sector 29, Gurugram, which was initiated by the HSVP vide request for proposal (RFP) (Annexure P-16) published in the month of February 2020.

Learned counsel for respondent No.2-Haryana Shahri Vikas Pradhikaran (HSVP) makes a statement that in a meeting, which was held yesterday i.e. 14.06.2021, the tender process, which was initiated, stands cancelled, rendering the writ petition infructuous.

Learned senior counsel for the petitioner states that with regard to the grievance, which the petitioner has highlighted in the petition against IDBI Bank (respondent Nos.4 and 5), he would make a detailed representation, which may be considered sympathetically.

In the light of the above, the present writ petition is disposed of as infructuous.

In case the petitioner makes an application/representation to respondent Nos.4 and 5 (IDBI Bank), the same shall be considered by it in accordance with law at an early date.
