In compliance with the order dated 14.10.2021 passed by this Court, affidavit dated 26.11.2021 of the District Development and Panchayat Officer, Jalandhar (respondent No.4) has been filed in Court, which is taken on record. Para No.4 of the said affidavit reads as under:

“4. That thereafter, respondent No.5 filed petition u/s 4, 5 & 7 of Punjab Public Premises and Land (Eviction and Rent Recovery) Act for ejectment of the respondents from property measuring 57k-14M being part and Parcel and comprised in Khasra no.23(14-0), 24 (2-07), 25(1-0), 32 (0-17), 33(1-7), 26(2-0), 27(10-18) 35 (0-17), 29(9-12), 30 (9-0), 31(1-12), 28(4-1), 33(1-7) 34 (0-18), 37(1-11), 39 situated at village Darapur Hadbast No.107, Tehsil Shahkot District Jalandhar and also for recovery of damages @ Rs.10,000/- per month being under unauthorized use and occupation of the respondents for the period 1-01-2000 to till the encroachment is removed. The true copy of Petition is

annexed herewith as Annexure R-4/2. The true Translation of Zimni order dated 19.10.2021 is annexed herewith as Annexure R-4/3.”

Counsel for the State on instructions from Mr. Rupesh Kumar Saddi, Panchayat Officer, Block Lohian Khas informs the Court that after the issuance of notices to the persons who are in illegal possession, the case is listed on 30.11.2021 for filing reply to the petition filed under Sections 4, 5 & 7 of the Punjab Public Premises Land (Eviction and Rent Recovery) Act.

In the light of above and keeping in view the fact that the office bearers of the Gram Panchayat of Village Muridwal, Tehsil Shahkot, Block- Lohian Khas, District Jalandhar have been suspended and proceedings have been initiated against them, we do not find any reason to continue with the present petition except for directing the concerned competent Court to finalize the above proceedings within a period of three months from today.

Writ petition stands disposed of accordingly.
