In pursuance to advertisement no. 9/2015 issued by the Haryana Staff Selection Commission, Panchkula, inviting applications for 625 posts of TGT English, Petitioner – Kavita Choudhary applied for the said post. The petitioner had not cleared the HTET Examination upto the last date of submission of application form and the same was to be cleared upto the date of interview. She passed her HTET Examination on 18.12.2015. Thereafter, the Commission had issued notice dated 13.1.2016 to the candidates for holding the written examination on 7.2.2016. The petitioner appeared in the written examination on 7.2.2016, the result of which was declared on 3.9.2016. The candidates were called for scrutiny of documents vide notices dated 1.12.2016 and 14.1.2017, however, the roll number of the petitioner was not figured in the list of candidates called for scrutiny of documents. The respondent-Commission vide notice dated

11.4.2019 called the petitioner of CWP No. 5198 of 2017 for security of documents, however, no separate list of the candidates has been issued for short-listing the candidates for interview. The petitioner approached the Commission with a written representation on 24.4.2019 with a request that she may be interviewed. However, she was not called for interview. Hence, the present writ petition directing the respondents to call the petitioner for scrutiny of documents and interview for the post of TGT English in terms of notice dated 11.4.2019 as she is in possession of the educational qualification as per service Rules and has also appeared in the written test and cleared HTET Test.

Vide order dated 17.5.2019, learned Single Judge had directed the State counsel to get the instructions as to how interviews for the posts of TGT (English) for all the categories, are being conducted especially when the Division Bench in LPA No. 56 of 2018 has stayed the result on the ground that some of the candidates, who were not eligible and even have not made applications, were deprived of their right for making suitable applications in time due to clarification given, which was ever made public.

Now the main case is listed for hearing on **13.7.2021**.

Today CM No. 5685-CWP of 2021 has been filed by the applicant-petitioner for withdrawal of the main writ petition.

Notice of the application to the counsel opposite.

Ms. Shruti Jain Goyal, learned Deputy Advocate General, Haryana, accepts notice and states that she has no objection if the present application is allowed and the main writ petition is permitted to be withdrawn.

On the oral request of counsel for the parties, the date of hearing of the main case is preponed from 13.7.2021 to today and taken up itself.

In view of the above, CM No. 5685-CWP of 2021 is allowed and the main writ petition is ordered to be dismissed as withdrawn.
