Petitioners have filed this petition under Section 482 Cr.P.C. for quashing of FIR No. 07 dated 15.03.2011, under Sections 452, 323, 324, 148 and 149 IPC (Section 325 IPC added later on) registered at Police Station

Tibber, Tehsil and District Gurdaspur and subsequent proceedings arising therefrom on the basis of compromise.

Vide order dated 29.11.2017, notice of motion was issued and the parties were directed to appear before concerned Trial Court/Illaq Magistrate for getting their statements recorded and the trial Court was to send its report regarding the genuineness of the compromise.

A report dated 12.12.2017 of learned Additional Chief Judicial Magistrate, Gurdaspur has been received. As per the report, the parties had appeared before learned Additional Chief Judicial Magistrate, Gurdaspur. Learned Magistrate has stated that the compromise is genuine, voluntary and without any coercion or undue influence.

In view thereof, the present petition is allowed, FIR No. 07 dated 15.03.2011, under Sections 452, 323, 324, 148 and 149 IPC (Section 325 IPC added later on) registered at Police Station Tibber, Tehsil and District Gurdaspur , along with all subsequent proceedings arising therefrom, are hereby quashed, qua the petitioners.
