This petition has been filed by the petitioners under Section 438 Code of Criminal Procedure for grant of anticipatory bail in case FIR No.63 dated 05.06.2021 under Sections 308, 341, 323, 506, 148 & 149 of Indian Penal Code, 1860 registered at Police Station Longowal, District Sangrur. The petitioners apprehended their arrest at the hands of Police, in the above FIR.

The FIR was registered on the statement of Pargat Singh and the allegations as noticed by the learned Additional Sessions Judge, Sangrur in the order dated 25.06.2021 are as under:

“As per allegations of the prosecution, on 30.05.2021 at about 9:00 PM when the complainant alongwith his family members tried to go his bed after taking the meal, the electricity of his house had gone and when he came out from his house to see the

fault, he has seen that Shamsheer Singh and his family members were trying to apply kundi connection illegally and when the complainant asked them as to why they have been getting the electricity illegally and caused fault in the light of his house, they started altercating with the complainant and the complainant went inside his house. Shamsheer Singh armed with iron rod, Arshdeep Singh armed with soti, Paramjit Kaur armed with soti, Manpreet Kaur armed with soti, Harpreet Kaur armed with soti and Channa Singh armed with soti chased him and wrongfully restrained him when he was going to his house. Paramjit Kaur raised lalkara by stating that taught him a lesson for raising objection against the kundi connection applied by them, on which Shamsheer Singh gave an iron rod blow which hit on the forehead of complainant, thereafter Paramjit Kaur gave soti blow which hit on the neck of complainant below his left ear, Shamsheer Singh gave another iron rod blow with an intention to kill him which hit in the middle of his head. He raised hue and cry on which his wife Paramjit Kaur came out from the house and when she tried to rescue him from the clutches of accused, they gave beating to Paramjit Kaur also, Shamsheer Singh gave 2/3 other iron rod blows which hit on the back of complainant. Arshdeep Singh gave danda blow which hit on his right thigh, Paramjit Kaur gave soti blow which hit on his right hand, Channa Singh gave soti blow which hit on his left knee, Manpreet Kaur and Harpreet Kaur also gave soti blows on his back. On raising hue and cry by the complainant and his wife, accused decamped from the place of occurrence with their respective weapons on seeing the people gathering there after giving threat to kill him. Complainant was got admitted to Civil Hospital, Sangrur by his brother Darshan Singh, but due to number of injuries on his person he was referred to Rajindra Hospital, Patiala and from Rajindra Hospital, Patiala he was referred to PGI,

Chandigarh.”

On 15.07.2021 the following order was passed:-

“Learned counsel contends that as per the allegations, the petitioners, who are ladies gave stick blows to the complainant, but the alleged injuries were found to be simple in nature. According to him, the complainant is neighbour of the petitioners, who has falsely implicated them.

Notice of motion for 30.07.2021.”

Learned counsel for the complainant has invited the attention of the Court to the order dated 25.06.2021 passed by Additional Sessions Judge, Sangrur, wherein, the number of injuries suffered by the injured have been noticed. He submits that the victim has suffered grievous injuries on head and therefore, the petitioners do not deserves the concession of anticipatory bail.

On the other hand learned State counsel assisted by ASI Ram Singh has pointed out that the co-accused of the petitioner namely Shamsheer Singh, who was armed with an iron rod already stands arrested and the injuries declared grievous in nature have been attributed to him. He on instructions from ASI Ram Singh further states that the injuries attributed to the petitioners were found to be simple in nature.

Considering the above background, it is ordered that in the event of arrest of the petitioners by the Arresting Officer, they shall be released on bail subject to their furnishing personal and surety bonds to the satisfaction of Arresting/Investigating Officer. They shall join

investigation as and when called for by the Investigating Officer and *would abide by the conditions enshrined under Section 438(2) Cr.P.C.*

However, it is made clear that the above observations shall not be construed as an opinion on the merits of the case.

The petition is allowed.
