The case has been taken up for hearing through video conferencing.

The petitioners, claiming themselves to be aged about 30 and 36 years respectively, have approached this Court seeking protection of their life and liberty on the averments that the petitioners, being major, performed marriage on 17.07.2021 at Shri Bhamri Devi Jan Kalyan Sanstha (Regd.), 222, Mata Mansa Devi Market, Sector-4, Pacnhkula, as per Hindu rites and ceremonies against the wishes of respondents No.3 and 4 and the petitioners are apprehending threat to their life and liberty at their instance.

In view of the facts and circumstances of the case and on oral request made by learned Counsel for the petitioners, U.T. Chandigarh and Senior Superintendent of Police, U.T. Chandigarh are ordered to be impleaded as respondents No.5 and 6. Memo of Parties be amended accordingly.

Notice of motion restricted to respondents No.5 and 6 only.

Mr. Y.S. Rathore, Addl. Public Prosecutor for U.T. Chandigarh, who is present in the video conferencing, has accepted notice on behalf of newly added respondents No.5 and 6.

Learned Counsel for the petitioners states that representation dated 17.07.2021 (Annexure P-4) was made to the Senior Superintendent of Police, Chandigarh seeking necessary protection but no action has been taken so far in the matter and prays

for issuance of direction in this regard.

Learned Addl. Public Prosecution has no objection if appropriate direction for providing requisite protection to the petitioners is given.

Without examining the question of legality and validity of the marriage and expressing any opinion thereon, the petition is disposed of with the directions to respondent No.6-Senior Superintendent of Police, Chandigarh to look into the grievances of the petitioners as set out in the petition and also expressed in the representation (Annexure P-4) and take appropriate action for protection of their life and liberty as may be warranted by the circumstances.

However, it is clarified that in case any criminal case has been/is registered against petitioner No.2, then nothing in this order shall be construed as a bar for taking of appropriate action by the police authorities against him in respect thereof in accordance with law.

Registry of this Court is directed to send a copy of this order along with copy of the petition and above-said representation to respondent No.6-Senior Superintendent of Police, Chandigarh for requisite compliance.
