These petitions have been filed under the provisions of Section 439 of the Cr.P.C., for grant of 'regular bail' to the petitioners in case FIR No. 312, dated 10.11.2020, registered at Police Station Division No. 8, Police Commissionerate, Jalandhar, for the alleged commission of offences punishable under the provisions of Sections 307/341/324/323/148/149 of the IPC.

A status report dated 09.12.2021 has been filed by the Assistant Commissioner of Police-IV, Model Town, Jalandhar, which is ordered to be taken on record.

As per the said report, the person shown as the victim in the FIR, i.e. Jatin Kumar, was examined at the AIIMS Sanjivani Hospital, Jalandhar, with the doctor having observed as follows:-

“This is certified that Mr. Jatin Kumar, 22 years/Male, s/o Jatinder Kumar r/o Ishwar Colony, Jalandhar was examined in person today. He came walking in my office. He is conscious/well oriented to free space and person.”

That being so, without making any comment on the actual merits of the case, with the petitioner having been in custody since 26.04.2021 and the report under the provisions of Section 173 (2) of the Cr.P.C having been submitted to the trial court, the petition is allowed.

The petitioner shall be admitted to bail upon his furnishing adequate bail bonds and surety bonds to the satisfaction of the learned trial court/Duty Magistrate/Chief Judicial Magistrate concerned.
