**Smt. Bala Versus Balbir Singh and others**

The matter is taken up in the Bi- Monthly Lok Adalat through video conferencing.

As agreed, as per statements of learned counsel for the appellant and the learned counsel for respondent No. 3–Insurance Company (separately recorded), a sum of Rs. 55,000/- (Rs. Fifty Five Thousand Only) over and above the amount awarded by the Tribunal, is ordered to be paid to the appellant as full and final settlement of his claim. As per the statement of learned counsel for the appellant, the enhanced amount be paid to the appellant.

Accordingly, we dispose of this case with a direction to the Insurance Company to deposit a demand draft for Rs.55,000/- in the name of the appellant in the office of the Lok Adalat of the High Court within four weeks from the date of receipt of a copy of this order, failing which, interest @ 9% per annum shall accrue on this amount till payment from the date of receipt of a copy of this order. The concerned Officer of the Lok Adalat Branch/Office shall issue a proper receipt to learned counsel for respondent No.3–Insurance Company, after receipt of the said demand draft. The appellant's counsel/appellant may collect the demand draft from the office of the Lok Adalat.

Learned counsel for the appellant as well as respondent No.3-Insurance Company undertake to submit the consent form duly signed/filled by both the parties, in the office of Lok Adalat.

Copy of the order be supplied/sent to the counsel/parties and file be returned to the Hon'ble High Court.
