The hearing of the case was held through video conferencing on account of restricted functioning of the Courts.

The learned counsel representing the petitioner has sent a scanned copy of the summons.

Learned counsel submits that the respondent has been served through his counsel on 20.08.2021. However, neither the respondent nor his counsel is present to contest the petition.

On 12.08.2021, the following order was passed:-
