CRM-9091 of 2021

This application has been filed by petitioner no.4 in the accompanying petition, seeking that the petition itself be disposed of in terms of the statements made by the parties before the learned trial court, pursuant to the order of this court dated 09.09.2020.

The petition is one seeking quashing of the FIR on the basis of a compromise stated to have been reached between the parties, with there being two reports received from the learned JMIC, Kapurthala, the last one being dated 17.12.2020, wherein it is stated that the statements of the complainant in the FIR, i.e. Gurmeet Kaur, as also of the victims (as alleged) Sansaar Singh and Jagjeet Singh, as also of the accused in the FIR, i.e. Rachpal Singh, Jeet Kaur, Kuldeep Singh, Jassa Singh @ Jaswinder Singh and Jaswinder Singh @ Shinda, were recorded as regards the compromise reached between the parties qua both, the FIR registered as also the cross version thereto, (registered vide

General Diary no.017, dated 30.07.2020).

[The FIR bears no.64, dated 09.06.2020, registered at Police Station Subhanpur, District Kapurthala, alleging therein the commission of offences punishable under Sections 323, 324, 326, 148, 149 and 188 of the IPC.

As regards the cross version thereto, that alleges the commission of offences punishable under Sections 323, 324, 148 and 149 of the IPC.]

As per the said report, none of the parties have any grievance left against each other and that none of them has been declared to be a proclaimed offender and further none of them were found to have been involved in any other case, as per the statement of one SI Gurjaswant Singh recorded before the learned Magistrate.

As per the assessment of that court, the compromise reached between the parties is without any threat, pressure or coercion.

That being so, this application is also allowed.

CRM-9395 of 2021

Vide this application, the same relief has been sought as has been sought in CRM-9091 of 2021. This application is also allowed and the date of hearing in the accompanying petitions is advanced to today itself, with the consent of all learned counsel for the parties.

Since counsel appearing in both cases today also stand by the compromise reached between the parties, both the petitions are allowed and FIR No.64, dated 09.06.2020, registered at Police Station Subhanpur, District Kapurthala, for the alleged commission of offences punishable under Sections 323, 324, 326, 148, 149 and 188 of the IPC, as also G.D. no.017, dated 30.07.2020, registered at the same police station, alleging therein the
