This order shall dispose of three petitions for regular bail; CRM-M-32575-2021, CRM-M-37984-2021 and CRM-M-38377-2021, all arising out of FIR No.36 dated 23.02.2021 under Sections 399/402/411/465/467/468/471/483/120-B IPC, Police Station Dirba, District Sangrur.

The case of the prosecution is that a secret information was received that Pawandeep Singh @ Pamma, Harmesh Singh @ Meshi (*petitioner in CRM-M-32575-2021*), Lovepreet Singh @ Lovi, Surinder Singh, Paramjeet Singh (*petitioner in CRM-M-38377-2021*) and four co-accused Jaspreet Singh @ Jassi, Sukhwinder Singh @ Laddi, Gurjot Singh @ Jot and Gopi (*petitioner in CRM-M-37984-2021*) were planning to rob either a petrol pump, liquor vend or indulge in snatching of vehicles. The secret information also disclosed that the accused had assembled at a particular place and had made preparations for committing dacoity. On receipt of the information a raid was conducted and Pawandeep Singh, Harmesh Singh-petitioner, Lovepreet Singh, Surinder Singh and Paramjeet Singh-petitioner were arrested from the spot. Two *kirchs* and three iron rods along with a car bearing registration No.PB13-AC-4343 were recovered from the accused. Four stolen vehicles are alleged to have been recovered on the disclosure statement of Paramjeet Singh.

The investigation in the case is complete. The petitioners are behind bars since 23.02.2021.

In view of the above, considering the period of custody and also

that due to Covid-19 restrictions, the conclusion of the trial may take time, without expressing any opinion on the merits of the case, these petitions are allowed.

The petitioners Harmesh Singh @ Ramesh Singh @ Meshi, Gupreet Singh @ Gopi and Paramjeet Singh @ Lalli are directed to be released on bail on their furnishing bail/surety bonds to the satisfaction of the Trial Court/Duty Magistrate concerned.
