CRM-37172-2021

This is an application filed under Section 482 of Cr.P.C. for withdrawal of the Criminal Revision.

It has been averred in the Criminal Revision that the petitioner had filed a complaint and on the basis of which, FIR No.145 dated 11.12.2010 was registered under Sections 147, 149, 323, 324 and 506 of the Indian Penal Code, 1860 and the trial Court had acquitted the private respondents vide judgment dated 29.01.2015 (Annexure P-3) and even the appeal against the same was dismissed by the Sessions Judge, Faridabad vide order dated 16.08.2016 (Annexure P-1). It is further stated that the petitioner alongwith the accused as well as private respondents have been living in harmony and want to maintain good relationship by forgetting the past and thus, the petitioner does not wish to continue with the present Criminal Revision.

Keeping in view the abovesaid averments made in the application, the present application is allowed.

Accordingly, the main Criminal Revision bearing CRR-4905-2016 stands dismissed as withdrawn.
