The matter is taken up in the National Lok Adalat through video conferencing.

As agreed, as per statements of learned counsel for the appellant and the learned counsel for respondent No. 3—Insurance Company (separately recorded), a sum of Rs. 70,000/- (Rs. Seventy Thousand Only) over and above the amount awarded by the Tribunal, is ordered to be paid to the appellant as full and final settlement of his claim in this appeal. As per the statement of learned counsel for the appellant, the enhanced amount be paid to the appellant.

Accordingly, we dispose of this case with a direction to the Insurance Company to deposit a demand draft for Rs. 70,000/- in the name of the appellant in the office of the Lok Adalat of the High Court within four weeks from today, failing which, interest @ 9% per annum shall accrue on this amount till payment from the date of this order. The concerned Officer of the Lok Adalat Branch/Office shall issue a proper receipt to learned counsel for respondent—Insurance Company, after receipt of the said demand draft. The appellant's counsel/appellant may collect the demand draft from the office of the Lok Adalat.
