Petitioners have filed this petition under Section 482 Cr.P.C. for quashing of FIR No. 36 dated 12.04.2020 under Sections 452, 323, 427, 384, 34 IPC registered at Police Station Sri Hargobindpur, Police District Batala, District Gurdaspur, and all other consequential proceedings arising out of the said FIR, as the matter stands amicably settled in terms of compromise dated 23.04.2020.

Vide order dated 10.12.2020, the parties were directed to appear before the trial Court/Duty Magistrate on 22.12.2020 for getting their statements recorded with regard to the compromise.

A report dated 15.01.2021 of learned JMIC, Batala, has been received. As per the report, the parties had appeared before learned JMIC, Batala and got recorded their statements regarding compromise. Learned Magistrate has stated that she is of the considered view that the compromise between the parties is valid, genuine, voluntary and without any coercion or undue influence.

In view thereof, the present petition is allowed. FIR No. 36 dated 12.04.2020 under Sections 452, 323, 427, 384, 34 IPC registered at Police Station Sri Hargobindpur, Police District Batala, District Gurdaspur, along with all subsequent proceedings arising therefrom, are hereby quashed qua the petitioners.
